ALLIANCE GRAIN TRADERS ANNOUNCES QUARTERLY DIVIDEND

REGINA, JUNE 28, 2010 - Alliance Grain Traders Inc. ("AGTI") (TSX:AGT) today announced its cash dividend for the quarter ending June 30, 2010 of \$0.135 per common share. The dividend will be payable on July 13, 2010 to shareholders of record on July 8, 2010. This dividend is an eligible dividend for Canadian income tax purposes. AGTI's current annualized cash dividend rate is approximately \$0.54 per share.

(AGTI) is a pulse processor and exporter engaged in the business of value-added processing (cleaning, splitting, sorting and bagging) of pulses and specialty crops, for export and domestic markets. Through its processing facilities located in some of the best pulse growing regions in Canada, the U.S., Turkey and Australia, AGTI handles a full range of pulses and specialty crops including lentils, peas, chickpeas, beans and canary seed. Through its subsidiaries in Turkey, the Arbel Group, AGTI also produces Arbella Pasta, rice, and milled wheat products, such as bulgur and semolina.
